
Listed below are commonly imported items.

-  **PROHIBITED PRODUCTS**
-  **INSPECTION REQUIRED**
-  **MUST BE TREATED** (may incur a treatment cost)

## FOOD

<b>BEANS, PEAS, CEREAL SEEDS</b> Includes handicrafts and souvenirs that container or are made from these seeds	
<b>BISCUITS, CAKES, CONFECTIONERY</b> Includes chocolate, sweets, crisps, roasted nuts, pretzels	
<b>EGGS</b> Includes whole, dried, powdered and uncooked egg products	
<b>FRUIT &amp; VEGETABLES – FRESH</b> (cooked, dried, frozen, canned or bottled are allowed)	
<b>FRUIT &amp; VEGETABLES – FRIED</b> Includes mushrooms, citrus peel or dried banana	
<b>HONEY</b> Includes royal jelly and propolis	
<b>BEE PRODUCTS</b> Includes honey comb and beeswax	
<b>MEAT – UNCANNED &amp; ALL PORK PRODUCTS</b> Includes fresh, dried, frozen, smoked or salted	
<b>MILK &amp; MILK PRODUCTS</b> Includes all products that contain milk ingredients (NZ dairy products and up to 1kg of baby formula per infant are allowed)	
<b>OTHER FOODS</b> Includes herbs and spices, breakfast cereals, Vegemite, flour, roasted coffee beans, jam, nutritional/dietary supplements	
<b>POPPING CORN, RAW UNROSTED NUTS</b> Includes raw peanuts, chestnuts (NZ chestnuts are allowed)	
<b>SALMON AND TROUT PRODUCTS</b> Ask about special import conditions	
<b>TEAS, COFFEE, KAVA, JUICE &amp; OTHER DRINKS</b> containing milk and/or eggs are prohibited	










## ANIMAL MATERIAL

<b>ANIMALS – LIVE</b> Includes birds, birds' eggs, fish, reptiles and insects	
<b>ANIMALS – STUFFED</b> (some may be prohibited by environmental laws) must be prepared by a taxidermist and have a certificate	
<b>BONES, HORNS, FEATHERS, SEASHELLS</b> Must be clean and free of blood, skin, faeces or soil	
<b>RAWHIDE</b> Includes rawhide drums, shields, other artefacts	
<b>SKINS, HIDES</b> must be professionally tanned or cured (some may be prohibited by environment laws)	
<b>WOOL, ANIMAL HAIR</b> Wool must be scoured and hair cleaned	








# Can you bring it in???

**YOU MUST DECLARE** all food, plant and animal goods.

## PLANT MATERIAL

<b>FLOWERS – FRESH &amp; LEIS</b> (flowers that may be propagated – for example, roses, carnations and chrysanthemums – are prohibited)	
<b>FLOWERS – DRIED</b> Arrangements containing grape vine, pine cones, cereal/grain seeds, straw will be treated.	
<b>HANDICRAFTS &amp; CURIOS</b> Includes carvings, items woven from palm fronds or leaves (banana leaf items must undergo treatment)	
<b>PINE CONES</b> Includes wreaths, decorations and dried arrangements	
<b>PLANTS – LIVE</b> Includes cuttings, roots, bulbs, corms, rhizomes and stems	
<b>POTPOURRI</b>	
<b>SEEDS</b> Small commercial packets, seed ornaments, necklaces (beans, corn and lettuce are prohibited)	
<b>STRAW OBJECTS</b> Includes corn dollies, wreaths and cereal grain decorations	
<b>WOODWARE, BAMBOO</b> Includes coconut carvings, cane baskets	

## OTHER MATERIAL

<b>ANIMAL EQUIPMENT – USED</b> Includes saddles, bridles, bird cages, grooming and veterinary equipment	
<b>BIOLOGICAL MATERIALS</b> Includes human & animal vaccines, veterinary therapeutics	
<b>HERBAL MEDICINES / REMEDIES</b> (some may require a Permit)	
<b>HOLY WATER</b>	
<b>PACKING MATERIAL / STUFFING</b> Includes fruit cartons, straw, raw cotton and raw wool (most other packing material is allowed)	
<b>SOIL, SAND</b> Includes items filled with soil or sand	
<b>THERAPEUTIC MEDICINES</b> (some may require a Permit)	
<b>VITAMIN / MINERAL SUPPLEMENTS , NUTRITIONAL / DIETARY SUPPLEMENTS</b> (some may require a Permit)
